REPORT OF JOINT SURVEY COMMITTEE ON RETIREMENT SYSTEMS

ASSEMBLY BILL 730

It is the feeling of the Committee that any expansion of the exclusion of service creditable for retirement purposes would be setting an extremely poor precedent. The Committee is sympathetic to the existing problem, but feels that the solution as purported in this bill will open the door to future undeserving legislation. If police and fire chiefs do not meet the established criteria for membership

as protective occupation participants perhaps they should be excluded from such membership and treated as general members instead. This matter could be referred to the Retirement Research Committee for a detailed study and recommendation. Consequently, it is the opinion of this Committee that *passage of this bill is not in the best public interest.*

ASSEMBLY BILL 637 AND ASSEMBLY AMENDMENT 1

The Retirement Research Committee developed standards and criteria for protective occupation coverage, which is contained in Chapter 355, Laws of 1967, and consequently positions not meeting the criteria were justifiably removed as of July 1, 1969.

If this bill is passed problems will develop in the following areas:

First, it would allow approximately 247 employees to elect to regain coverage as protective occupation participants, even though they do not meet the eligibility criteria for such membership, if they so elect. The amendment will allow approximately 229 employees to regain coverage as protective occupation participants if they so elect.

Second, the employer contribution costs could be increased from \$72,000 to \$719,302 for the next biennium depending upon how many participants elect and whether or not the amendment to the bill is enacted. 100% of the costs would be paid from segregated funds.

Third, the bill establishes a very poor precedent, which completely subverts the intent of Chapter 355, Laws of 1967.

Therefore, it is the opinion of this Committee that this bill and assembly amendment 1 thereto *is not in the best public interest and is not deserving of passage.*
