# REPORT OF JOINT SURVEY COMMITTEE ON TAX EXEMPTIONS

### ASSEMBLY BILL 47

### Public Policy Involved

This proposal is undesirable. To exempt admission charges at events where professional entertainment is not "a major attraction" is bound to lead to disputes over what constitutes a "major attraction". Few social, fraternal, neighborhood, or work groups which convene for a banquet, dance, picnic or to sponsor a sports show or fair where professional entertainment is present would admit that the entertainment was the "major attraction", although it may have been that in the minds of those who attended.

#### ASSEMBLY BILL 219

### Public Policy Involved
