**REPORT OF JOINT SURVEY COMMITTEE  
ON TAX EXEMPTIONS**

**Assembly Bill 858**

**Public Policy Involved**

This bill is not desirable as a matter of public policy. It was intended to limit the exemption for manufacturers to those who produce, by machinery, a new article with a different form, use and name. This bill broadens that definition to benefit a special group, the tire retreaders. If this bill were passed, it would be difficult not to extend a similar exemption privilege to others who rebuild, rework, refurbish or recondition previously manufactured items.

**Public Policy Involved**

Under this proposal, units of local government would lose the 60% personal property tax credit on livestock now paid by the state with the result that real estate and the other personal property in a tax district would be required to pay more taxes.
