JOINT SURVEY COMMITTEE ON TAX EXEMPTIONS

Assembly Bill 420 and Senate Bill 293

Public Policy Involved

This proposal is not desirable as a matter of public policy. It involves a serious question as to its legality. In addition, it would seem to be poor public policy at this time to add another organization to the list of organizations which may hold tax exempt property in their own names.

Public Policy Involved

If the rationale for this proposal is to stimulate increased political contributions, it's doubtful that a \$1 tax credit will provoke such change. To the extent that some percentage of the state's 2,000,000 or more taxpayers claimed this credit, general purpose revenues would be decreased at the expense of public needs provided for out of the general fund. This bill is undesirable as a matter of public policy.

Public Policy Involved

Under this proposal, units of local government would lose the 60% personal property tax credit on livestock now paid by the state, with the result that real estate and other personal property in a tax district would be more heavily taxed. This bill is undesirable as a matter of public policy.

Assembly Bill 930

Public Policy Involved

This bill is desirable to the extent that it imposes a gasoline tax on those people who would benefit from the expenditure of the funds collected on gasoline sold at marinas. However, each county's share of the tax distribution which it may use for maintenance and improvement of water-related recreation projects, will depend on the presence or absence of gasoline-selling marinas within its boundaries.

Other solutions are possible. Tax distributions could be made to counties on the basis of miles of shoreline or amount of open water, or the funds could be retained by the state and spent by it in the same type of program.

In its present form, this bill is not desirable as a matter of public policy.

Public Policy Involved

This bill is not desirable as a matter of public policy. The sales tax is a tax on the gross receipts of sales made by retailers; sales by vending machines are retail sales. Vending machines compete with retail establishments selling tangible personal property. It is unfair to give a competitive advantage to vending machine operators by exempting their sales while continuing to tax other retailers selling the same merchandise.

JOINT SURVEY COMMITTEE ON RETIREMENT SYSTEMS

Assembly Bill 831

The bill is in conflict with the legislative intent of Chapter 355, Laws of 1967, which was enacted as the result of a detailed study conducted during 1967 by the Retirement Research Committee. The bill is objectionable because it further complicates a very difficult situation, fails to clarify pertinent questions, or completely ignores them. Therefore, it is the opinion of this Committee that passage of this bill is not in the best public interest.
