*Resolved,* That the committee is directed to review the types of planning conducted in and regulatory measures proposed by other states and the federal government, together with the experience of those other states and the federal government in implementing such planning and regulation, to determine if there is a need for such regulation in Wisconsin, utilizing the legislative council for research, legal and secretarial assistance; and, be it further

*Resolved,* That the committee report its findings and recommendations to the 1973 legislature when it convenes.
