# REPORT OF JOINT SURVEY COMMITTEE ON RETIREMENT SYSTEMS

#### Assembly Bill 541

Due to the questionable funding provisions contained in the bill, as well as the failure to grant increased benefits to all retirees of the various Wisconsin state supported retirement systems, passage of this bill would appear inappropriate at this time. This committee feels that the matter of post-retirement adjustments should be re-refered to the Retirement Research Committee for study and subsequent preparation of corrective legislation. The committee further feels that he bill and assembly amendment 1 are not in the best public interest or deserving of passage at this particular time.
