for unequally profitable purposes have been introduced; now, therefore, be it

Resolved by the assembly, That the assembly committee on agriculture may conduct a study and investigation of all questions related to the desirability of and the ways and means best to accomplish preferential taxation of agricultural and open space lands; and, be it further

Resolved, That the assembly agriculture committee may hold hearings anywhere in this state at the discretion of the chairman, subpoena witnesses and acquire evidence relating to the study and investigation mentioned in the previous paragraph. The committee may meet during the period the 1971 legislature is in session and during the interim and shall report its findings and recommendations to either or both the 1971 legislature or 1973 legislature when it convenes.
