INTRODUCTION AND REFERENCE OF RESOLUTIONS

Read and referred:

Assembly Resolution 51

Requesting the U.S. secretary of agriculture to simplify DES certification requirements for cattle shipped to slaughter for use as human food.

Whereas, the federal government, to prevent residues of diethylstilbestrol (DES) in the meat of cattle and sheep slaughtered for human consumption, now requires the withdrawal of feeds containing DES 7 days prior to slaughter, and requires that each separate shipment of cattle for slaughter be accompanied by individual certifications by owners or shippers to the effect that such animals have in fact been withdrawn from feeds containing DES, as prescribed under federal regulations; and

Whereas, food and drug administration regulations (21 CFR 121.241, 21 CFR 135e.18) absolutely prohibit the use of DES in feeds for dairy and breeding animals; and

Whereas, the certification as directed under such regulations imposes a huge paperwork burden on the Wisconsin livestock industry, wholly unnecessary to the accomplishment of basic objectives of DES regulations, namely, the protection of public health, not only with respect to the frequency of certification reports, required for individual shipments when periodic reports would accomplish the same purpose, but also in the certification of dairy cattle, which in any event are not and cannot be fed on feed containing DES under federal regulations; now, therefore, be it

Resolved by the assembly, That the U.S. secretary of agriculture be urged to amend section 309.16 of the meat inspection regulations (9 CFR 309.16) to 1) exempt dairy

and breeding cattle from DES certification requirements in that the use of DES in feeds for dairy and breeding cattle is already prohibited, and 2) provide for longer term certification of feeder cattle shipments to eliminate the necessity of individual certifications; and, be it further

Resolved, That certified copies of this resolution be transmitted forthwith to the U.S. secretary of agriculture and each member of the congressional delegation from Wisconsin.

Whereas, high property taxes directly damage not only people but force agricultural and open space lands to be devoured by galloping urban sprawl; and

Whereas, other sources of funds must be channeled into support for local educational facilities and operations instead of hopelessly relying on the property tax; now, therefore, be it

Resolved by the assembly, That, as a first step to greater state support of local educational and other costs, it is declared to be the sense of the assembly that 100% of the budget surplus, as reported in Governor Lucey's recent budget review message, be devoted to property tax relief and paid as real property tax relief under s. 79.10.
