GOVERNOR'S VETO MESSAGE

To the Honorable, the Assembly:

I am today returning Assembly Bill 452 without my approval.

Assembly Bill 452 provides in part for statewide venue in certain sex crimes prosecutions. Specifically, the pertinent portion of the bill states that:

"Where the offense is in violation of ss. 944.01, 944.02, 944.06, 944.10, 944.11, 944.12 and 944.17, it is only necessary that the state prove the event occurred in this state to establish venue."

The Attorney General has rendered to my office an opinion dated December 20, 1971, indicating that Article 1, Section 7, of the Wisconsin Constitution, which provides that an accused shall enjoy the right to a public trial in the county or district wherein an offense shall have been committed, opining that the proposed statute is unconstitutional insofar as it attempts to create a statewide district for the trial of sex crimes.

For the above-mentioned reason, I do not feel it would be appropriate to sign Assembly Bill 452 into law at this time.

To the Honorable, the Assembly:

I am returning Assembly Bill 1009 without my approval.

The material part of Assembly Bill 1009 reads as follows:

"RETIREMENT LAW EFFECTIVENESS. Every person who is a participating employe under chapter 41 of the statutes on the effective date of this law (1971), and every person who is an active member under chapter 42 of the statutes on the effective date of this law (1971), shall be entitled to receive all benefits, regardless of whether such

benefits may be deemed prospective or retroactive, under chapters _____ (Senate Bill 503 or Senate Bill 526 or both), laws of 1971."

The effective date for the liberalized retirement benefits proposed in Senate Bills 503 and 526 is July 1, 1972. Assembly Bill 1009 would permit members of the Wisconsin Retirement Fund, Chapter 41, Stats., and the State Teachers' Retirement System, Chapter 42, Stats., retiring between the effective date of Assembly Bill 1009 and the effective dates of Senate Bills 503 and 526, to receive the liberalized benefits of these later bills.

The precedent represented by this bill, in creating an effective date for proposed legislation not yet considered or enacted by the legislature could lead to undesirable pressures in the enactment or consideration of such legislation, and could institute a new system of legislating which would be contrary to the public interest. For example, it seems particularly inappropriate to establish an effective date for legislation involving public expenditures of funds prior to the passage of the bills which would authorize the expenditure of such funds.

An argument can be made that the legislation intended to provide equity for those employes who have given long service to the State of Wisconsin and whose mandatory retirement age of 65 will have occurred prior to the effective date of proposed legislation which would otherwise substantially improve their retirement status. I am sympathetic to that concern and have dealt with it in the following ways:

- (1) I have encouraged the several state agencies to extend the mandatory retirement age option until March 31, 1972, and again until July 1, 1972, so that all employes who would otherwise have retired prior to those dates will be permitted to continue their employment with the state in the event that the legislature enacts the various retirement improvement proposals which are now pending before it.
- (2) I am requesting that Senate Bill 503, which currently provides for increased retirement benefits in the Wisconsin Retirement Fund to be effective July 1, 1972, be amended so that employes retiring prior to July 1, 1972, and after passage of that legislation, if it is in fact enacted by the Legislature, would be eligible immediately for such increased benefits.

(3) Chapter 125, Laws of 1971, included a provision whereby retired employes could exchange unused sick leave credit for the purchase of health insurance. These provisions were to become effective on July 1, 1972. I have proposed in Assembly Bill 1477 that these provisions become effective upon passage of that bill so that employes who would normally be retiring would immediately be eligible for those significant benefits.

In view of the above actions which I have taken to protect the interest of employes nearing retirement from state service and for the above mentioned reasons relative to the public policy of th proposed legislation, I do not think it would be in the public's interest to sign Assembly Bill 1009 into law at this time.
