Assembly Resolution 55

Urging President Nixon to order public hearings on the revised environmental impact statement on the trans-Alaska oil pipeline and to delay his decision on the pipeline project to permit full public disclosure and comment.

Whereas, the construction of the proposed 789-mile trans-Alaska oil pipeline is about to receive a quick approval by President Nixon, *without public hearings*; and

Whereas, the oil pipeline threatens to destroy the nation's last unspoiled frontier by the massive bulldozing, road construction and gravel excavation efforts prior to its operation and, later, by the very real possibility of the pipeline breaking, spewing hot oil into unspoiled rivers and streams and onto our untouched wilderness lands; and

Whereas, oil spills caused by the ocean transport and loading and unloading operations would pollute some of the most productive and beautiful marine habitats in the world; and

Whereas, the environmental impact statement has been prepared in secret by government technicians and the oil companies without consideration of the public interests involved and without public hearings; and

Whereas, the public has a right to a meaningful role in the decision-making process and must have access to the environmental impact statement and to the technicians and politicians that drafted the statement by the means of public hearings; now, therefore, be it

Resolved by the assembly, That President Nixon is urged to order public hearings held on the now-secret environmental impact statement and that he defer any decision on

the pipeline project for at least 60 days after the impact statement is made public to permit full public disclosure and comment; and, be it further

Resolved, That duly attested copies of this resolution be transmitted immediately to President Nixon, the secretary of the interior and to each member of congress from this state.
