Dear Mr. Fox:

The Wisconsin Department of Justice has received your recent request for a formal opinion on the constitutionality of 1971 Senate Bill 138 and assembly substitute amendments 1 and 2. For the following reasons, I do not feel it necessary or appropriate to render such an opinion at this time:

I call your attention to a formal opinion of the Attorney General's Office found in 52 OAG 207 (1963). That opinion concerned a similar legislative proposal which would have provided for tax deductions to parents of private school children. The basic concept of such a deduction is found in the proposed legislation for which you seek an opinion.

The 1963 Attorney General's opinion found such a concept to be unconstitutional. On November 11, 1969, my office reexamined the matter of giving grants to parents of students attending non-public schools and discussed various court cases up to that time. I determined upon such examination that the law in this area was as follows:

If the constitutionality or unconstitutionality of these bills were clear, I would feel obligated to so advise you. However, with Wisconsin adopting in *Warren v. Reuter, supra*, the "primary-effect" test, I am unable to look beyond the words of public purpose enunciated in the bills. Because of the importance of this matter to our education system and to the people of this state, I must advise that the constitutionality can only be determined by the state Supreme Court where it can be measured against the facts of a specific case.

In addition, I should note that since issuance of my November 11, 1969 formal opinion to the Wisconsin Senate and Assembly, there have been no additional Wisconsin Supreme Court cases bearing upon the question.

In view of the above, I feel it unnecessary to render another formal opinion at this time on the contents of 1971 Senate Bill 138 and assembly substitute amendments 1 and 2. Copies of the 1963 and 1969 opinions by this office are attached.
