BEFORE THE CLAIMS BOARD OF WISCONSIN

A hearing was held at Madison, Wisconsin, on June 3, 1970, upon the following claim.

Dane County claims \$7,174.78 as reimbursement for costs incurred on February 12, 1970, in providing extraordinary police services for the preservation of order and protection of State property in the vicinity of the Madison Campus of the University of Wisconsin. This protection was requested by University officials to quell disturbances during placement interviews by General Electric Corporation and incurred prior to the effective date of Chapter 374, Laws of 1969, which created Section 16.008 of the Wisconsin Statutes.

In view of the fact that the state has a duty to provide protection for University students as well as protection for state property, the claim in the adjusted amount of \$6,403.15 is one which the state on equitable principles should assume and pay.

BEFORE THE CLAIMS BOARD OF WISCONSIN

A hearing was held at Madison, Wisconsin, June 3, 1970, upon the following statement of charges submitted to the Board on behalf of Dane County.

Pursuant to Section 16.008, Wisconsin Statutes, Dane County claims \$5,691.85 as reimbursement for special charges incurred on February 13 and 19, 1970, in providing extraordinary police services at the request of University of Wisconsin officials in the vicinity of state-owned property for the purpose of the protection and preservation of such state property. Campus disturbances were caused by protestors objecting to placement interviews by General Electric on February 13 and by the commencement of an unauthorized strike by University teaching assistants on February 19, 1970. Excepting for an adjustment in determining fringe costs and vehicle damage previously reimbursed, payment of the claim in the amount of \$5,218.13 is one which is proper and should be allowed and paid as authorized by such section.
