# INTRODUCTION OF RESOLUTIONS

#### Senate Resolution 7

Relating to a study of employe retirement pension funds and the need for regulations thereof.

# JOURNAL OF THE SENATE [February 12, 1971]

This resolution requests a study by the senate committee on Labor, Taxation, Insurance and Banking, of the fairness and functions of private pension plans.

Whereas, thousands of Wisconsin citizens are participants in private pension plans and have planned their retirement years on the expectation of benefits from these pension plans, and this expectation has been an employment benefit; and

Whereas, these citizens participate in private pension plans with the expectation that such participation will mean greater economic security during their retirement years, and in the belief that this promise is supported by adequate and prudently managed funds to guarantee its fulfillment; and

Whereas, investigation and study has shown that this promise of benefits and retirement security has not always been fulfilled; and

Whereas, business reorganizations, business and pension fund insolvencies, involuntary retirements, inadequate funding, imprudent investing, and employment facility terminations and relocations, among other things, have in some cases affected the anticipated benefits; and

Whereas, the soundness and fairness of pension plans and their fulfillment or failure to fulfill the promise of security and well-being is a matter of concern to the legislature of Wisconsin; now, therefore, be it

Resolved by the senate, That the senate committee on Labor, Taxation, Insurance and Banking conduct an investigation and study of private pension plans, their findings, and the vesting of rights of participants in such pension programs in Wisconsin; and particularly, without limitation because of enumeration:

- (1) Review present state and federal laws which are applicable and review the functions and repsonsibilities of state departments and agencies in regard to the general question.
- (2) Consider whether or not there should be specific laws regarding the vesting of interests of participants in private pension plans and full reporting of the status of such plans to individual participants.
- (3) Consider whether or not there should be specific laws concerning the funding of pension plans and the management and investment of pension funds.

- (4) Consider whether or not there is a correlation between the involuntary retirement from private pension plans prior to eligibility for FICA benefits (Social Security) and job discrimination on the basis of age.
- (5) Consider whether there should be a specific state agency with the responsibility and authority to regulate private pension plans and funds.
- (6) Determine what legislation, if any, is necessary to safeguard the interests, expectations and rights of pension plan participants.
- (7) Propose such legislation, if any, which may be appropriate in the context of the findings of the committee; and, be it further

Resolved, That the senate committee on Labor, Taxation, Insurance and Banking shall conduct such public hearings in such parts of the state as determined by the chairman; and be it further

Resolved, That the senate committee on Labor, Taxation, Insurance and Banking shall complete its investigation and submit its final report to the legislature no later than 18 months after the adoption of this resolution or January 5, 1973, whichever date is sooner, and that the necessary staff and secretarial service for the committee be provided by the legislative council.
