Requesting the opinion of the attorney general with regard to the constitutional validity of any law resulting from the enactment of 1971 Assembly Bill 210.

Whereas, 1971 Assembly Bill 210 is now before the senate; and

Whereas, during the assembly debate on 1971 Assembly Bill 210 it was held that said bill did not require referral to the joint committee on Finance "because of the minimal and speculative nature of a possible fiscal note"; and

Whereas, it is a common principle of parliamentary law that the second house may not inquire into the procedures of the house of origin but must presume their validity, nevertheless the senate feels constrained to question whether the assembly's allegation of a possible fiscal effect of said bill—albeit "minimal and speculative"—and that body's subsequent failure to refer the bill to the joint committee on Finance in accordance with section 13.10 (1) of the statutes has made further legislative consideration of the bill inappropriate without corrective action; and

Whereas, section 16.47 (2) of the statutes raises the question of whether, prior to the passage of the general fund executive budget, a bill with fiscal implications may be passed by the house of origin unless it is accompanied by a statement to the effect that it is an emergency bill and recommended either by the governor or by the joint committee on Finance; now, therefore, be it

Resolved by the senate, That the attorney general be requested to render his official opinion, as expeditiously as possible, with regard to the constitutionality and legality of the procedures attendant to the legislative action, thus far, concerning 1971 Assembly Bill 210, and with special reference to the ruling of the supreme court of this state in the case of *State ex rel. General Motors Corporation v. Oak Creek* (49 Wis. 2d 299), decided January 5, 1971.

Appendix to Senate Bill 83

Public Policy Involved

This proposal is undesirable as a matter of public policy. That this bill would change corporate investment patterns enough to reduce the interest rates on future bond issues is doubtful. Moreover individuals who invest in this type of security do so because of federal income tax rates in the higher brackets in which they find themselves. Granting this exemption will result in an income tax reduction to persons with a high taxable income with little compensating decrease in the state and local government bond interest rates.

Public Policy Involved

This proposal is not desirable public policy. States commonly make arbitrary but crucial distinctions between residents and nonresidents on the basis of what is best for the state, its subdivisions and its citizens. If this exemption is extended to include pleasure craft of nonresidents, the tax base of some Wisconsin communities which already have financial problems will be further diminished.

Public Policy Involved

This is desirable public policy. When the sales tax law of 1970 was enacted it was the legislature's intent to exempt feeds, seeds and other supplies used by farmers in raising livestock and crops. An exemption requires specific definition, but the original act failed to list semen. This bill corrects that oversight.

This proposal would prevent a motion to recall a bill from committee from taking effect prior to hearing if such has been scheduled.

Resolved by the senate, That senate rule 41, of the 1969 Rules of the Senate, is amended to read:

SENATE RULE 41. (1) Any bill, resolution or other matter may be referred at any time previous to its passage, *except that in no case shall a motion to recall from committee take effect prior to a committee hearing if such has been scheduled when the motion to recall is made.* A motion to recall, re-refer or withdraw shall be in order, but the question shall be divisible, and the senate having once refused to recall a bill, resolution or other matter from committee, such action shall constitute a final disposition thereof unless such refusal to recall is reconsidered under rule 67 and if not so reconsidered a second motion to recall shall not be in order.
