Senate Resolution 14

Relating to inviting the governor to present his views on a merger of institutions of higher education.

Analysis by the Legislative Reference Bureau

This resolution formally invites Governor Patrick J. Lucey to present his viewpoint to the senate on the proposed consolidation of the university of Wisconsin and the state universities.

Whereas, the people of the state of Wisconsin have developed and supported 2 public university systems, the university of Wisconsin, "UW", and the state university system, "WSU", in which they take a befitting pride for accomplishments which range from educating thousands of their sons and daughters to scientific coups for which Nobel Prizes have been bestowed; and

Whereas, these institutions with the solid financial backing of Wisconsin's taxpayers afford an educational opportunity to Wisconsin's young people of a quality and diversity heretofore unavailable; and

Whereas, proposals have been made to combine these great systems into a single system with one administration, with the most recent notable proposal, which undoubtedly is the result of substantial staff work and study, having been made by the Honorable Governor of Wisconsin, Patrick J. Lucey, who has stated that:

The present organizational system of our two universities is archaic and the product of historic accident; a merger

would "end costly and unseemly rivalries between the two systems"; there is "expensive duplication of graduate programs", and such a consolidation "... would provide greater educational benefit to the undergraduates of the state in a more economical fashion."

The governor has charged "that the present two-university system fosters competition of an invidious nature that demands equality and cannot tolerate innovation".

The governor has declared: "Merger of the UW and WSU systems will obviously lead to greater administrative efficiencies and cost savings".

Whereas, the members of the senate are most concerned with giving this merger proposal the most careful consideration and with giving the people of this state in their several communities the opportunity to express their views and concerns, before the legislature acts; and

Whereas, the anticipated state biennial budget for the 2 university systems is in excess of \$486 million, or about 25% of the total biennial budget for general purposes, which together with its other funding sources make the university systems the largest state "enterprise"; and

Whereas, in the past other governmental reorganizations have been made because it was said by the proponents that greater efficiency and economy would result with improved quality of operation, and after the reorganization it has been difficult to descry increased efficiency or find dollar savings or to discern any improvement of quality of output, but to the contrary the increased centralization has often resulted in agencies which are in fact less responsive to the people and their legislature; and

Whereas, the members of the senate are concerned that the effect of the consolidation into one super system of 2 of the largest state operations could be to homogenize the quality of education and perhaps cause the several institutions to lose their identity, their traditions and achievements of excellence of which the citizens of this state are justifiably proud, and which consolidation might create a system of such vastness that it may become unresponsive to the people and their legislature in a manner inconsistent with the traditions of democracy; now, therefore, be it

Resolved by the senate, That the Honorable Patrick J. Lucey, Governor of the State of Wisconsin is invited to meet, at a convenient time in the senate chambers, with the Wisconsin senate sitting as a committee of the whole to present information which supports his statements and to give more detail concerning the merger which he advocates, and to give the members of the senate the benefit of the staff study and research which relates to this consolidation proposal; and, be it further

Resolved, That a special hearing and fact-finding committee is created to consist of 6 senators including 2 from the minority party, appointed as are members of standing committees:

(1) To hold public hearings in several areas of the state as determined by the committee; and

(2) To gather facts and information regarding the effects of such a consolidation as proposed; and

(3) To submit a summary of their hearings, together with an analysis of the effect of such a consolidation to the senate.
