## **INTRODUCTION OF RESOLUTIONS**

Whereas, on several occasions in the past the attorney general's office of this state has held that the applicable provisions of our state constitution require the university of Wisconsin to be located at the seat of government (i.e. at Madison) and prevent a consolidation of the university of Wisconsin with public colleges located elsewhere in the state; e.g. 1925 O.A.G. 194 and 1955 O.A.G. 120; now, therefore, be it

*Resolved by the senate*, That the attorney general be requested to render, as expeditiously as practicable, his official opinion with regard to the constitutional questions raised by the proposed merger of the university of Wisconsin and the state universities system.
