This bill is undesirable as a matter of public policy. Exempting the receipts from special events like carnivals, circuses, dances and other activities sponsored by municipal fire departments and volunteer fire companies as well as the receipts from the sale of tangible personal property would be inequitable with respect to other fraternal, social or neighborhood groups, and discriminatory in relation to merchants or entertainers who sell the same tangible personal property or provide entertainment but must pay tax.
