Requesting the opinion of the attorney general with regard to pending proposals for the merging of the university of Wisconsin and the state universities into a single system.

Whereas, 1971 Senate Bill 213 proposes to abolish the separate boards of regents of the university of Wisconsin and of the state universities and to create, in their stead, a single board of regents to administer a consolidated system into which all institutions now under the control of the 2 separate boards have been merged; and

Whereas, a similar proposal has been advocated by the governor and is, in fact, incorporated into his proposed executive budget; and

Whereas, on several occasions in the past the attorney general's office of this state has held that the applicable provisions of our state constitution require the university of Wisconsin to be located at the seat of government (i.e. at Madison) and prevent a consolidation of the university of Wisconsin with public colleges located elsewhere in the state; e.g. 1925 O.A.G. 194 and 1955 O.A.G. 120; and

Whereas, the university of Wisconsin now maintains full campuses including graduate schools at Madison and Milwaukee, 4-year campuses at Green Bay and Parkside and, in addition, seven 2-year extension centers at Baraboo, Wausau, Marshfield, Janesville, Sheboygan, West Bend and Waukesha; now, therefore, be it

Resolved by the senate, That the attorney general be requested to render, as expeditiously as practicable, his official opinion with regard to the constitutional questions raised by the proposed merger of the university of Wisconsin and the state universities system.
