#### Analysis by the Legislative Reference Bureau

The senate rules presently permit their suspension by vote of 2/3 of the members present. This resolution changes that to permit suspension by vote of a majority of those senators present.

---

*Resolved by the senate,* That senate rule 90 is amended to read:

RULE 90. These rules may be suspended by the senate by vote of *a majority* of the members present. The vote shall be determined by ayes and noes unless unanimous consent is given.

### Senate Resolution 38

To amend senate rule 8 (2), relating to the time in which the presiding officer must rule on points of order.

---

#### Analysis by the Legislative Reference Bureau

The senate rules presently authorize the presiding officer to defer ruling on a point of order for up to 5 legislative days. This resolution reduces that period to one legislative day.

---

*Resolved by the senate,* That senate rule 8 (2) is amended to read:

SENATE RULE 8. (2) Whenever a point of order is raised, the presiding officer may rule thereon forthwith, or may defer his decision ~~not to exceed five~~ *until no later than the same time on the next legislative day* to enable him to examine into the precedents. In the case of questions
