Appendix to Senate Bill 265 and Senate Amendment 1

Public Policy Involved

Under the present sales tax law, the Wisconsin printing industry has been placed at a disadvantage in competing with out-of-state printing firms. Printed matter may be shipped into Wisconsin for storage and subsequently distributed outside the state without tax consequence to a purchaser. However, delivery by a Wisconsin printer to a Wisconsin purchaser of printed material for advertising purposes is subject to tax even though that material is subsequently distributed and used in advertising the customer's products outside this state. The proposal eliminates the distinction between the business location of the vendor. It is desirable as public policy.
