INTRODUCTION OF RESOLUTIONS

Senate Resolution 48

Relating to a study comparing local government salaries to those paid in private industry.

Analysis by the Legislative Reference Bureau

This resolution presents salary comparisons as to Milwaukee public officers and asks the new joint committee on local government revenue to consider these and other salaries paid by local government in its study of tax distribution.

Whereas, an ongoing, comparative study of wages and salaries paid in the public and private sector of Milwaukee

city and county shows an inbalance in favor of public employes, according to figures gathered continuously since 1956 by the Public Expenditure Survey of Wisconsin; and

Whereas, there is evidence that most of this one third of the public employes sampled are being paid up to \$3,000 more per year in some instances, 50% more in others, than workers holding equivalent posts in private business and industry; and

Whereas, Milwaukee aldermen now recieve \$2,451 more per year than state legislatures and with new pay boosts enacted, those same aldermen will annually be paid \$5,543 or 62% more than state legislators come next April—for jobs with a much lower responsibility level than those of the state lawmakers; and

Whereas, the mayor of Milwaukee already draws a public salary \$5,270 in excess of that of the governor of Wisconsin each year and in April, 1972, will be raised to a stipend \$11,351 or 45% more than the governor's annual pay for a job with a much lower responsibility level than that of the governor; and

Whereas, limited information prevents any detailed statistics comparing salaries attached to jobs in other local government to those paid by private enterprise, though it is apparent results of such a study could be startling if the Milwaukee table of organization signals a trend; and

Whereas, personnel costs are a major factor in rocketing expenses of local government; and

Whereas, it appears a futile exercise in governmental wheel-spinning to attempt to revamp distribution without taking a long, hard look at the reasons behind upthrusting costs of local government-like population density, low property valuations and excessive personnel costs; and

Whereas, an impartial review of salaries and wages paid across the state to public workers in contrast to the compensation received by their counterparts in private enterprise could furnish immensely helpful facts to the legislature in handling the thorny problem of recasting state tax distribution; now, therefore, be it

Resolved by the senate, That the proposed joint committee on local government revenue resources in senate substitute amendment 2 to Senate Bill 713 shall take cognizance of the

foregoing facts and particularly the disparity between public and private salaries for equal work which appears to exist in the Milwaukee area, in the course of its work to develop meaningful tax distribution formulae; and, be it further

Resolved, That the city and county of Milwaukee and other local units of government throughout the state are hereby urged to make every effort to bring their personnel costs in line with those of private industry and business, which together with their employes must bear the burden of public employment costs.

"Resolved, That the legislative council is hereby directed to study and compare salaries and wages of local govern-

ments as contrasted to pay for similar work for private enterprise and to report its findings and recommendations for correcting unbalance in this area to the 1973 legislature when it convenes; and, be it further".

Senator McKenna moved reconsideration of the vote by which Senate Bill 213 was ordered to a third reading.

Senator Keppler moved that the motion to reconsider Senate Bill 213 be laid on the table.

Senator Keppler moved the senate adjourn until 2:00 P.M. Tuesday, September 21.
