In case of duplication or of overlapping areas of original inquiry the committee on senate organization shall define and delimit the subject matter area assigned to each committee and determine the scope of the inquiry conducted by each committee.

REPORT OF JOINT SURVEY COMMITTEE ON RETIREMENT SYSTEMS

Appendix to Senate Bill 740 and Senate Amendment 1

Recommendation

The aim of public agency retirement systems is to provide fair and equitable treatment to all participants. However, this bill will provide certain benefits to a few select members while disregarding the other 65,000 members. This Committee feels that the whole matter of previous service credit should undergo *comprehensive study by the Retirement Research Committee. Consequently, it is the opinion of this Committee that passage of this bill is not in the best public interest. If the bill is passed, however, it is recommended that senate amendment 1 be adopted.*

Appendix to Senate Bill 795

Recommendation

This bill will standardize the treatment of inactive retirement accounts for the various state supported retirement systems. The legislation is badly needed in order that
