EXECUTIVE COMMUNICATIONS

December 16, 1971.

To the Honorable, the Senate:

I am returning Senate Bill 394 without my approval.

Senate Bill 394 would transfer the responsibility for the examination of applicants for funeral director and embalmer licenses and the making of reciprocal agreements with other states concerning such license standards from

the Department of Health and Social Services to the Funeral Directors and Embalmers Examining Council. The Kellett Commission reorganization of 1967 placed the responsibility of determining standards for funeral directors and embalmer licenses and making reciprocal agreements with other states in the hands of the Department of Health and Social Services. In practice, both before and after the 1967 Kellett reorganization, examinations and reciprocal agreements with other states have continued to be the function of the examining council, although ultimate authority rests with the Department of Health and Social Services. There are a number of other examining councils attached to the Department of Health and Social Services that are controlled and operated under the same organizational structure within the Department of Health and Social Services as is the Funeral Directors and Embalmers Examining Council.

Because signing this bill would cause inconsistent treatment of several examining councils attached to the Department of Health and Social Services, and because this bill weakens departmental control with regard to the examining council, I do not think it would be in the best interests of the State of Wisconsin to sign this bill into law at this time.
