Whereas, as the first American president ever to visit China, Mr. Nixon has taken a great stride forward toward ushering in an era of peace in the hope of resolving to an early settlement the Indochina war; and

Whereas, world peace is now a possibility as a result of this, the most significant peace thrust ever conceived and executed by a leader of the American people; and

Whereas, the president's face-to-face meetings with China Premier Chou En-lai and party Chief Mao Tse-tung may well mark the opening of a new chapter in more meaningful Sino-American relations; now, therefore,

The Members of the Wisconsin Legislature, on the motion of Senator Lorge, under Joint Rule 26, resoundingly applaud and firmly support President Nixon and the members of his entourage in their worthy journey to China to pave the way to a lasting peace; and, be it further
