We consider the provisions of **Senate Bill 899** or **Assembly Bill 629** as amended to be essential for the implementation of the Wisconsin Air Quality Program as required in 1972 by the Federal Clean Air Act. If necessary statutory authority is not given the Wisconsin Department of Natural Resources, the only available alternative may be promulgation of federal regulations for the State of Wisconsin.

Because of the urgency of this matter, we have taken the liberty of sending similar telegrams to the Attorney General, Senator Krueger and Representative Mittness.
