The Joint Committees of the Legislature, the Assembly Committee on Veterans' and Military Affairs and the Senate Committee on Governmental and Veterans' Affairs, met for an Executive Session November 11, 1972 at 10:30 A.M., to act on Enrolled Assembly Joint Resolution 20.

The Executive Session was called to order by the Chairman, Representative William P. Atkinson. Committee members present were:

Present: Representative Atkinson, Representative Mato, Representative O'Malley, Representative Oberle, Representative Early, Representative Menos, Representative Kafka, Representative Schricker, Representative Klicka, Co-Chairman; Senator Roseleip, Senator Lotto and Senator Lourigan.

Absent: Representative Merkel, Representative Gaulke, Senator Knutson and Senator Lipscomb.

Representative Gaulke, Senator Knutson and Senator Lipscomb called their vote in. A quorum was present and Enrolled Assembly Joint Resolution 20 was taken up.

The Executive Session opened with a question and answer period by the members of the Joint Committees. John R. Moses, Secretary of the Department of Veterans Affairs, was asked to be present for informational purposes and responded to the questions put to him. Jerry Sessions, of the Department of Veterans Affairs, was also present for informational purposes.

The discussion covered the testimony of the hearings held on Enrolled Assembly Joint Resolution 20, in the Southeastern part of the State. (The synopsis and brief analysis of the hearing transcripts is attached to this report for your information).

There was discussion on the possibility of recommending investigating the feasibility of Turn-Key construction and contracting for services for a second Veterans' Home. This was introduced as an amendment to Senator Lourigan's motion by Representatives Michael Early and David O'Malley. It was moved by Representative Early and seconded by Representative O'Malley, that we add to Senator Lourigan's motion the amendment that the Legislature investigate the possibility of Turn-Key construction and also investigate contracting for services. In a call of the roll, all members responded with an aye vote and the amendment became part of the motion. Representative Early stated he would also like to see a Veterans' Home in the Northwestern part of the State and Representative Mato stated he would like to see one built in the Western part of the State.

The action on Enrolled Assembly Joint Resolution 20 was as follows:

It was moved by Senator Lourigan and seconded by Representative Menos, that the Senate Committee on Governmental and Veterans' Affairs and the Assembly Committee on Veterans' and Military Affairs, in joint action pursuant to Assembly Joint Resolution 20, report to the Legislature that it has found there is need for the establishing of a second State Home for Veterans, similar to King, in the southeastern part of Wisconsin and that it is feasible at this time to study the site for and to commence planning for such home and recommend to the Legislature that it proceed immediately with the site study and planning and investigate the possibility of Turn-Key construction of such facility and the possibility of contracting for essential supportive services for such second State Home for Veterans.

On call of the roll, the motion was adopted on a roll call vote, with 15 members voting for adoption, no members voting against adoption and one member absent or not voting.
