INTRODUCTION AND REFERENCE OF RESOLUTIONS

Whereas, the governor's task force on offender rehabilitation has, in its recently released final report, recommended the phasing out of the Wisconsin prisons and that convicted prisoners be placed in community-based facilities; and

Whereas, it appears from the petition presented to Governor Patrick J. Lucey on or about November 2, 1972, and from the general report for citizens sentiment on this issue that this recommendation may not be well-advised; and

Whereas, it is reported that the executive budget to be presented to the legislature by the governor on February 1, 1973, for the 1973-75 biennium may drastically reduce the recommended appropriation for operation of the Wisconsin state reformatory and the Lincoln boys school resulting in their closing by the end of the biennium; and

Whereas, it is anticipated that by the same method the governor will recommend the sale of the Adams county juvenile facility to the federal government and the phasing out of operation or closing of the Kettle Moraine boys school; and

Whereas, the assembly desires to elicit intelligent reaction and expert opinion on the desirability or advisability of these moves prior to those recommendations of the executive budget in order to render that recommendation more intelligent and responsive; now, therefore, be it

Resolved by the assembly, That the assembly hereby directs its committee on health and social services, between February 15 and March 19, 1973, to conduct at least one public hearing on the proposed referendum to citizens at each of the following locations: Madison, Waukesha, Hayward, Merrill, Green Bay, and Fond du Lac, and at such other locations as the committee deems advisable, and that the committee fully reports the contents of these hearings to the assembly by no later than April 1, 1973; and, be it further

Resolved, That the assembly hereby empowers its Committee on Health and Social Services to exercise the powers specified under section 13.45 of the statutes for legislative committees, and to compel testimony in conjunction with these hearings so that a record of these proceedings is had and maintained.
