JOINT SURVEY COMMITTEE ON  
RETIREMENT SYSTEMS

**Assembly Bill 23**

It is the feeling of the Committee that the provisions of Sections 20 thru 27 will provide equal treatment for all beneficiaries under the three state-supported retirement systems, irregardless of sex and therefore, it is the opinion of this Committee that passage of the bill is in the best public interest.

To Joint Survey Committee on Tax Exemptions.

**Assembly Bill 32**

The bill is incomplete and extremely vague. It refers to the transfer of funds, that in all probability are non-existent, to a Retirement Fund without implementing instructions to the receiving Fund. The bill does not accomplish its rather indistinct purpose and is largely a defective bill. Therefore, it is the opinion of this committee that passage of this bill is not in the best public interest.

**Assembly Bill 363**

This bill allows a member, who has moved or will move from one state supported retirement system to another, to transfer his retirement credit and benefits. It provides retirement benefits for participants as though such participants had remained in one state

supported system, rather than two or more, until retirement. An intrastate reciprocity program has been critically needed in this state for over two decades.

Over 50% of the states have presently implemented a program of intrastate reciprocity. It is advantageous to the State in its role as a recruiter and employer as well as to the members of the retirement systems involved. The expense of establishing retroactive reciprocity appears quite small, while the expense of contemporary reciprocity, for all practical purposes, is non-existent.

For the above reasons it is the opinion of the Committee that this bill is definitely in the best public interest and is deserving of passage.
