JOINT SURVEY COMMITTEE ON TAX EXEMPTIONS

Assembly Joint Resolution 1

Public Policy Involved

This joint resolution which amends the uniformity clause for agricultural and undeveloped land is intended to authorize the legislature to grant property tax relief for farmers and preserve open spaces for recreational and other ecological uses. If fully implemented by subsequent statutes, it will do both. Its effect, however, if not cautiously implemented, may well be erratic.

For example, assume that the value of agricultural land under present standards is 50% in a tax district and that under the implementation proposal the tax levy on agricultural land decreases 33%, then the levy on the remaining 50% of land will increase by 33%. If agricultural land is one-fifth of all property in a district the decrease in the levy on agricultural land will be 45% and the resulting increase on all other property will be 10%. On the other hand, where agricultural land is four-fifths of all property in a district, then the levy on agricultural land will decrease 18% and the resulting increase on all other property will be 66%.

This joint resolution would authorize the legislature to preserve land in open space by removing much of the economic necessity for converting land to urban uses experienced by a farmer whose farm is assessed at speculative value. On the other hand, removing the

incentive to vacate the farm on the urban fringe will in some cases require that urban development leapfrog that farm in a manner often referred to as urban sprawl.

Although this proposal has desirable public policy features, this committee recognizes that less than cautious implementation of its goals could offset its beneficial effects. For these reasons the committee feels that its approving recommendation must be qualified with the suggestion that examples of enabling legislation dealing with these impediments be created and reviewed at the time this joint resolution is under consideration.
