Whereas, the cost of milk has increased .04/gal into the store, butter .02/lb into the store and cheese .01/lb in the past 3 months; and

Whereas, the cost of poultry products, formerly one of the bargains in the meat market, has risen dramatically in the past 2 months with eggs increasing in cost by 20% and chicken going from \$.27-1/2/lb. to \$.47-1/2/lb., an increase of 73%; and

Whereas, the cost of choice heifers in carload lots has risen from .46/lb. to .66/lb. in 3 months and the price of pork trimmings used to make pork sausage went from .28-1/2/lb. to .50/lb. in the same time period; and

Whereas, Wisconsin is a leading agricultural state with a great portion of the state's economy depending on agri-business with an interest in determining the reasons for the tremendous cost increases in food prices in recent months; now, therefore, be it

Resolved by the assembly, That the assembly hereby directs its committee on agriculture to conduct hearings and study the reasons for these great increases in the cost of food and to report its findings to the assembly, along with recommendations for possible action that could be taken at the state level, as well as

recommendations to the congress of the United States for national action to alleviate the tremendous burden placed on consumers by the rising prices of food; and, be it further

Resolved, That the assembly hereby empowers its committee on agriculture to exercise the powers specified under section 13.45 of the statutes for legislative committees, and to compel testimony in conjunction with its hearings so that a record of the proceedings is had and maintained.

RULING ON THE POINT OF ORDER

On March 14, 1973, Representative Earl moved that Assembly Bill 128 be withdrawn from the calendar of March 15 and referred to the Joint Committee on Finance.

Representative Shabaz made the parliamentary inquiry as to whether the motion required a suspension of the rules and thus a two-thirds vote or whether it required a simple majority. The chair took the point of order under advisement.

It is obvious that if the motion had been made when Assembly Bill 128 was before the Assembly on the calendar of March 15, the motion would require a simple majority. This would be true whether the bill were required by statute to be referred to the Joint Committee on Finance prior to passage or not. Under Assembly Rule 18, bills appear on the printed calendar for action by being referred there by the presiding officer or by recommendation of a

standing committee. The question before us, simply stated, is whether taking some action on a bill that is on a calendar ahead of the business that the Assembly is currently working on, constitutes taking a bill up out of order and therefore a violation of Assembly Rules 17 and 18 relating to the calendar and regular orders of business.

On March 2, 1971, Speaker Huber ruled that a motion to withdraw a bill from a future calendar and refer it to the Joint Committee on Finance required a suspension of the rules since it constituted an advancement of the bill ahead of its regular consideration under the rules. Advancement of the bill ahead of its regular consideration, as expressed by Speaker Huber at the time, apparently referred to taking the matter up prior to its normal time of consideration, and did not involve a determination that the particular measure had to go to the Joint Committee on Finance prior to passage and thus a motion to refer the bill to the Joint Committee on Finance constituted advancing the bill closer to passage.

There is one additional precedent from the Senate. On June 2, 1939, a motion was made to refer a bill from a future calendar to a committee. Upon a parliamentary inquiry as to whether that motion involved a suspension of the rules and required a two-thirds vote, Senator Rush, then presiding, held that the motion did involve a suspension of the rules and required a two-thirds vote.

On the basis of the foregoing precedents, the Chair feels compelled to rule that any motion to refer a bill on a future calendar to a committee involves a suspension of the rules and therefore requires a two-thirds vote.
