INTRODUCTION AND REFERENCE OF RESOLUTIONS

Read and referred:

Assembly Resolution 23

To amend assembly rule 47 (3); and to create assembly rule 40, relating to the substitution of prior assembly action when concurring in senate bills.

Analysis by the Legislative Reference Bureau

Nothing in the rules of the Wisconsin Legislature, or of either house thereof, prevents the introduction, consideration and approval of identical bills in both houses. Sometimes, the result is that each house passes its own version of the identical text, and then spends the same amount of time again when considering the other house's version for concurrence.

This proposal (which is patterned after a practice in use in the Florida legislature), would permit the assembly to substitute its earlier actions on the assembly version for the detailed 3-readings consideration of an identical senate bill.

The proposal applies to bills only. As to bills, it probably does not violate the requirements of sections 17 and 19 of article IV of the constitution. However, it would appear that the wording of section 1 of article XII of the Wisconsin constitution would prevent the application of a similar procedure to joint resolutions proposing constitutional amendments.

Resolved by the assembly, That:

SECTION 1. Assembly rule 40 is created to read:

Assembly Rule 40. Substitution of identical bills. Whenever the assembly has passed a bill, giving it the 3 readings required under the rules, and has messaged such bill to the senate, the assembly may, if it subsequently receives from the senate a bill identical to the assembly bill so passed and messaged, by unanimous consent and on the motion of the majority leader substitute its prior action on the assembly bill for the 3 separate readings of the senate bill. Granting of the unanimous consent to substitute the prior action shall be deemed an affirmative waiver of the assembly's right to amend the senate bill under section 19 of article IV of the constitution of this state.

(1) For any senate bill concurred in by the substitution procedure, the record shall show an entry substantially as follows: "(Date) Concurred in; see prior action on assembly bill _____".

(2) If the senate bill to which the substitution procedure is to be applied is of such a nature as to require a recorded roll call vote on concurrence, then the vote on concurrence shall be taken immediately following the granting of unanimous consent for substitution.

SECTION 2. Assembly rule 47 (3) is amended to read:

Assembly Rule 47 (3) ~~Every~~ Except as provided in assembly rule 40, every bill shall receive 3 separate readings prior to passage or concurrence.

SECTION 3. Printing of engrossed assembly rules. Within one week from the adoption of this resolution the chief clerk, if at that time there are no other assembly resolutions pending to change the assembly rules which, in the judgment of the chief clerk, will probably be agreed to by the members of the assembly so as to further change the assembly rules, shall cause the printing of this resolution as adopted by the assembly, and incorporating the entire text of the assembly rules. The document so printed shall be deemed the engrossed copy of this resolution.
