### INTRODUCTION AND REFERENCE OF RESOLUTIONS

Read and referred:

#### **Assembly Resolution 24**

To renumber assembly rule 77 (title and text); to repeal and recreate assembly rule 35 (1); and to create assembly rule 77 (title) and (2), relating to prior review of certificates under joint rule 26 by the committee on rules and prohibiting motions for en masse disposition of pending business.

---

#### Analysis by the Legislative Reference Bureau

This resolution creates 2 new rules of assembly procedure:

(1) All proposed certificates under joint rule 26 originating in the assembly must be approved by the committee on rules before they are put on calendar for consideration. All certificates approved for consideration are to be placed on a Thursday calendar (i.e., Thursday would be the only day on which the assembly considers such certificates).

(2) Any motion to consider pending business en masse is held out of order, even if a specific motion for en masse consideration has the approval of unanimous consent or of a two-thirds vote, and no member is obliged to vote on a motion for disposal of pending business en masse. The rule is so stated that it is still possible to treat a bill and all its pending substitutes and amendments as a single whole which could, for instance, be tabled or indefinitely postponed by a single motion to that effect.

NOTE: Existing assembly rule 35 (1) deals with bill introduction after the "deadline"; inasmuch as both houses have repealed their bill introduction deadlines, the existing text of assembly rule 35 (1) is obsolete and the proposed rule on certificates is located in its place.

Resolved by the assembly, That:

SECTION 1. Assembly rule 35 (1) is repealed and recreated to read:

Assembly Rule 35 (1) Consider certificates under joint rule 26 presented to it by members for introduction. Any certificate approved by the committee for introduction shall be reported to the assembly in writing, and its consideration shall be placed on a Thursday calendar under the proper order of business. Any certificate which the committee does not approve for introduction may be returned to the authors by the committee.

SECTION 2. Assembly rule 77 (title and text) is renumbered to be assembly rule 77 (1).

SECTION 3. Assembly rule 77 (title) and (2) are created to read:

Assembly Rule 77 (title) **Voting.**

(2) **NO DISPOSITION EN MASSE.** Any motion to dispose of pending business en masse is out of order and may not be permitted either by unanimous consent or two-thirds vote. No member is required to vote on the disposition of any pending business unless the motion to dispose of the business is so stated as to permit the member to cast his vote for or against the proposed disposition of a specific item of business. In the case of a proposal, "specific item of business" shall mean and include the original proposal as well as all amendments or substitute amendments thereto.
