JOINT SURVEY COMMITTEE ON TAX EXEMPTIONS

Assembly Substitute Amendment 1 to Assembly Bill 300

Public Policy Involved

Items (1) and (2). The increases in the individual income tax personal exemptions and the resulting changes in filing requirements are desirable public policy because they narrow the effect of the differences between the federal deduction for personal

exemptions when compared to the state's credit against income tax and they recognize the effect of inflation on the value of the exemption credit. Unlike changes in the federal deduction for personal exemptions, this change in Wisconsin's personal exemption credit will provide proportionally greater benefits to lower income taxpayers.

(Item (3).) It is desirable public policy to eliminate the tax cost on furnishing nutritional meals to elderly and handicapped persons who either are unable to prepare their own meals or lack facilities for such preparations. However, the present wording does not limit itself to this result.

(Item (4).) The exemption for meals to college students will benefit those students who live in a dormitory. The amount of sales tax paid by these students is not a significant element in their budgets. Other students, who live in rooming houses where they are not permitted to prepare meals, will be required to continue to pay sales tax on meals purchased. Inasmuch as some senior citizens and other persons live under similar conditions and must pay the sales tax on all purchased meals, this proposed exemption would give special consideration to a particular group and not to others similarly situated.

(Item (5).) The purchase, installation and construction of pollution abatement plant and equipment, when ordered or approved by a governmental agency, is desirable public policy. Elimination of sales tax on materials used for acquisition or construction of pollution abatement facilities helps promote this goal.

(Item (6).) It is inconsistent to exempt food from the 4% general sales tax and, at the same time, apply a tax on oleomargarine which is equivalent to a rate of from 10% to 31%, depending on the price of the particular brand. This tax exemption provision would be desirable public policy if the tax savings would be passed on to the consumer. Because this is doubtful, however, this provision is not desirable public policy.

Item (7). Exemptions are presently granted from the excise tax on alcoholic beverages for alcohol used in manufacturing, and it is desirable public policy to grant a similar exemption for wine so used.

These services all add up, but they probably will never add up to the \$350,000 in medical assistance charges dispensed to its indigent patients each year; now, therefore,
