guaranteed by the fourteenth amendment to the U.S. constitution and by the Wisconsin constitution, either by denying him equal opportunity of employment or otherwise?

3. Whether the state, counties, municipalities and other governmental units are denying a person whose mobility is limited because of his physical condition, including a person in a wheelchair, his right under the U.S. and Wisconsin constitutions to access to the seats of government?

4. Whether the state, counties, municipalities and other governmental units and owners and managers of other public buildings and places of employment as defined in section 101.01 (2) (a) and (h) of the statutes are denying a person whose mobility is limited because of his physical condition, including a person in a wheelchair, his right under the U.S. and Wisconsin constitutions to travel and freedom of movement?

5. Whether the state, counties, municipalities and other governmental units and owners and managers of other public buildings and places of employment as defined in section 101.01 (2) (a) and (h) of the statutes have an affirmative duty to provide a person whose mobility is limited because of his physical condition, including a person in a wheelchair, with equal access to such buildings and places of employment?
