Whereas, Article XI, section 3 of the Wisconsin Constitution, empowers cities and villages "to determine their local affairs and government, subject only to this constitution and to such enactments of the legislature of statewide concern as shall with uniformity affect every city or every village."; and

Whereas, section 62.04 of the statutes states that the powers of cities and villages "shall be liberally construed" and section 62.11 (5) of the statutes states that the powers "shall be limited only by express language."; now, therefore, he it

Resolved by the assembly, That the attorney general is requested to provide an opinion as expeditiously as possible as to the constitutionality of and necessity for Assembly Substitute Amendment 1 to 1973 Assembly Bill 95 for the adoption of rent control ordinances by one or more cities or villages with special reference to the opinion of the attorney general dated October 26, 1950. (39 Ops. Atty. Gen. 407 (1950)).

### **Assembly Resolution 36**

Memorializing Congress to take immediate action to nationalize the oil industry.

Whereas, oil is one of our most important finite resources and decisions made by policy-makers in the oil industry affect many aspects of our lives; and

Whereas, the question of who runs the oil industry and for what purpose is of vitally important concern to all Americans; and

Whereas, the policy-makers of the giant oil corporations have much influence on governmental policy, as presently U.S. department of interior officials sit with oil company executives on committees of the National Petroleum Council (N.P.C.), which together with the American Petroleum Institute (A.P.I.) form the bicameral legislature of the private government of oil; and

Whereas, a prime example of the use of such influence was in 1971 when the U.S. state department undertook a major act of diplomatic intervention on behalf of the multinational oil companies, the Organization of Petroleum Exporting Countries (O.P.E.C.) and the Middle East producing nations, in helping to create an international oil cartel that may have provided substantial impetus to the energy crisis in the United States; and

Whereas, there is seemingly a basic contradiction in the facts concerning the alleged energy shortage as the U.S. Office of Emergency Preparedness has reported that 562 gasoline stations have closed as of June 1973, and the present fuel crisis also threatens to drive out another 1,376 stations, while the fact remains

that the U.S. oil corporations imported close to 4.7 million barrels of oil daily in 1972 and will increase that by over 27% to 6 million barrels daily in 1973; and

Whereas, this contradiction can be answered when we realize that the main crisis in energy is that energy sources are becoming more and more monopolized, and this concentration of economic power means a redistribution of wealth, income and political power in the wrong direction; and

Whereas, taxpayers already foot the welfare bill for these multi-billion-dollar corporations as can be seen in the latest available government statistics which show that taxpayers dole out about \$1.6 billion per year in the form of oil depletion allowances; and

Whereas, that dole amounts to nearly 4 times the amount devoted to the "Head Start" program for preschool children -- 21 times the funds for the Neighborhood Youth Corps -- 8 times as much as is spent for on-the-job training of veterans -- 18 times the federal support for the arts and humanities; and

Whereas, the driving force behind corporate decisions is the maximization of profit, which is becoming more and more incompatible with social well-being, as can clearly be seen in the Alaskan Pipeline venture; and

Whereas, huge private corporations no longer fill their traditional role as a boon to the American people and have become organizations which no longer serve the best interests of the American people; now, therefore, be it

Resolved by the assembly, That the Congress is urged to take immediate action to nationalize the oil industry so that the citizens of the United States may be served by rather than be servient to the oil empire; and, be it further

Resolved, That duly attested copies of this resolution be transmitted to each member of the congressional delegation from Wisconsin.
