INTRODUCTION AND REFERENCE OF RESOLUTIONS

Read and referred:

Assembly Resolution 40

Urging congress to immediately end our participation in the war in Southeast Asia.

Whereas, the people of Wisconsin have always held sacred the right to life and have strongly supported the right to have the lives of all people protected by law; and

Whereas, the Wisconsin legislature has the responsibility to prohibit the destruction of innocent life; and

Whereas, the war that was never declared but was concluded with "honor" last January continues to eat up money, weapons and lives; and

Whereas, since the signing of the Paris peace accords public pressure in the United States for an end to U.S. intervention has dwindled rapidly -- one major reason being that news about our Cambodian military operations has diminished almost to the point where it makes Watergate read like an open book; and

Whereas, the facts we do have show that between the January 27th cease-fire and May 1, U.S. planes dropped 82,837 tons of bombs on Cambodia which is smaller than Oklahoma yet has a population of 6 million; and

Whereas, in addition to the Cambodian pulverization U.S. planes have dropped 63,082 tons of bombs in Laos; and

Whereas, the U.S. air force has been given blanket authorization to conduct tactical air strikes and B-52 raids in Cambodia and averages 60 strikes per day which is a 700% increase from 2 years ago; and

Whereas, refugees currently represent about one-third of Cambodia's population and are victims of B-52's which are dropping an average of 1,800 tons of explosives daily; and

Whereas, the full extent of the carnage, especially that caused by the B-52's which are capable of obliterating a 110 acre area in one 3-plane mission, will probably never be known but most relief workers estimate the average civilian toll at no less than 1,000 dead each week; and

Whereas, dimensions of the bombing as depicted by Pentagon figures between January 27 and May 1 show U.S. forces bombed, shelled, napalmed, paid salaries for bomber pilots and lost equipment in Indo China costing more than \$258 million; and

Whereas, the President's action in Cambodia is being pursued without any apparent constitutional basis; now, therefore, be it

Resolved by the assembly, That the assembly expresses its strong disapproval of the Southeast Asian actions; and, be it further

Resolved, That the assembly strongly urges the congress to immediately end our participation in the war in Southeast Asia and to withhold funds for that war.
