Requesting an attorney general's opinion as to the legality of the voting procedures of the joint committee for review of administrative rules and particularly the executive vote of that committee on MVD 24.03 (5) taken July 9, 1973.

Whereas, the joint committee for review of administrative rules is a vital joint standing committee of this legislature, created by statute and consisting of 4 senators and 5 representatives; and

Whereas, the committee's procedural rules are essential to its responsible operation; and

Whereas, there are 29 joint rules of the senate and assembly, none of which establish the right of an absent committee member to vote, designate the time, if any, that a roll call vote can be kept open, or deal with related questions of joint committee procedure; and

Whereas, assembly rule 22 (4) and (5) explicitly provides,

"A committee shall act only when together, and all votes shall be taken in the presence of the committee. A member shall not be recorded as voting unless he was actually present in the committee when he voted."

and

"Any vote in an executive session may be held open until the adjournment of that committee session to permit an absent member to vote; but such vote shall only be recorded if the member votes in the presence of the committee in session."

; and

Whereas, senate rules are silent on the subject of the voting procedures of the joint committee for review of administrative rules; now, therefore, be it

Resolved by the assembly, That the attorney general is requested to issue an opinion at the earliest possible date as to the legality of permitting an absent member of the joint committee for review of administrative rules to vote, and as to the length of time, if any, allowed for a roll call vote of that committee to remain open; and, be it further

Resolved, That the attorney general is in addition requested to issue an opinion on the legality of the July 9, 1973 executive vote of the joint committee for review of administrative rules dealing with MVD 24.03 (5).
