The Wisconsin State Assembly goes on record favoring the impeachment of Richard M. Nixon.

Whereas, we hold these truths to be self-evident, that all men are created equal, that they are endowed by their creator with certain inalienable rights, that among these are life, liberty and the pursuit of happiness, and that to secure these rights, governments are instituted among men, deriving their just powers from the consent of the governed; and

Whereas, whenever any form of government becomes destructive of these ends, it is the right of the people to alter or to abolish it, and to institute new government; and

Whereas, members of the house of representatives are the only elected representatives who can institute impeachment proceedings; and

Whereas, the president has denied the citizens of the United States equal protection under the law by holding himself out above the law and the courts, and equal protection is guaranteed both in the constitution and in the oath of President to the American people; and

Whereas, the firing of Special Prosecutor Cox deprives the American people of their only guarantee that a fair, thorough, and judicious investigation would be carried out; now, therefore, be it

Resolved by the assembly, That former Special Prosecutor Archibald Cox, former United States Attorney General Elliot Richardson, and former Deputy United States Attorney General William Ruckelshaus are commended for their vigorous pursuit of truth and justice; and, be it further

Resolved, That all Wisconsin citizens are urged to let their feelings on the President's action be known to the Wisconsin congressional delegation; and, be it further

Resolved, That President Richard M. Nixon place national unity above partisan political convictions and resign; and, be it further

Resolved, That the members of the Wisconsin Assembly endorse the impeachment of President Richard M. Nixon in the event that his resignation is not forthcoming so that liberty and justice for all will prevail in this country; and, be it further

Resolved, That duly attested copies of this resolution be immediately transmitted to the President of the United States, the secretary of the United States senate, the chairman of the committee on judiciary and the chief clerk of the United States house of representatives; and, be it further
