JOINT SURVEY COMMITTEE ON
RETIREMENT SYSTEMS

Assembly Bill 969

This Committee believes that any significant changes in the protective occupation benefit plan of the WRF should await the studies and recommendations, if any, of the Retirement Research Committee. This bill would represent a significant change in the retirement law and, therefore, should not be acted upon at this time.

Assembly Bill 1036

It is the finding of this committee that **Assembly Bill 1036** does not reflect the criteria, as developed by the Retirement Research Committee and as enacted into law (Section 40.80), for the recognition of military service for retirement purposes in an equitable, reasonable and standard manner. This Committee, therefore, recommends against the passage of this bill.

Assembly Bill 1174

This bill would establish a poor precedent and could subvert and circumvent the legislative intent as to the qualification for "protective occupation" benefits in the WRF.
