Whereas, Mr. Kraemer rose from a 6th grade education to become a self-made man who had sincerity of purpose, admiration and respect for his employees, and firm religious convictions. His great personal compassion for each of his workers, his strong self-discipline as a leader of men, and his fantastic ability to transform ideas into action and thus devising methods to do a better job were the cornerstones on which his life was built; and

Whereas, Edward Kraemer's involvement in community affairs encompassed serving 52 years as a trustee of the Village of Plain; playing a leading role in the religious affairs of St. Luke's Catholic Church, and actively involving himself in the Republican Party at the county, state, and national levels; and

Whereas, Mr. Kraemer was made a Knight of St. Gregory, a papal honor, in 1948 for his civic contributions, he was fourth degree member of the Knights of Columbus, and he had been previously honored by the National Road Builders Association and Lions International; and
