Requesting, again, an attorney general's opinion on the procedure for acting on constitutional amendments proposed on 2nd consideration.

Whereas, on October 26, 1973, this assembly by 1973 Assembly Resolution 37 submitted to the attorney general a series of 4 questions regarding the 2nd consideration of the constitutional amendment proposed to this legislature by 1971 Enrolled Joint Resolution 26, and the attorney general issued his formal opinion on February 15, 1974; and

Whereas, the questions submitted to the attorney general were addressed, specifically, to the issue of whether or not this legislature may divide the amendment proposed by 1971 Enrolled Joint Resolution 26 into its 2 component parts and approve, on 2nd consideration and for immediate submission to the people for ratification, only one of the 2 component parts; i.e., in the manner proposed by 1973 Assembly Joint Resolution 46 as affected by the adoption of assembly amendments 1, 2 and 4 thereto on May 1 and July 19, 1973, respectively; and

Whereas, the same issue had been raised by 1973 Assembly Joint Resolution 30 and substitute amendment 2 thereto; and

Whereas, the office of the attorney general previously advised in 54 Att. Gen. 9 that any difference in wording of the proposed constitutional text means that the amending process has to be started anew as a 1st consideration; and

Whereas, the formal opinion received in response to 1973 Assembly Resolution 37 appears addressed only to the alternative of a single or separated ballot question, and in no way answers the assembly's more basic question pertaining to separated approval by this legislature of a single part of the 2-component proposition approved by the 1971 legislature; and

Whereas, a full and complete reply to this fundamental constitutional question is important not only to guide this legislature in its proceedings, but also to guide the legislative reference bureau in preparing proposed constitutional amendments for 2nd consideration, and to the secretary of state in determining whether or not a proposed constitutional amendment was validly approved by 2 successive legislatures so as to qualify for submission to the people; now, therefore, be it

Resolved by the assembly, That the attorney general is again requested to provide his opinion, as expeditiously as possible, in regard to the questions originally submitted to his office by 1973 Assembly Resolution 37 and as further explained in this present resolution; and, be it further

Resolved, That the attorney general is requested to render his formal opinion to this legislature on whether or not 1973 Asssmbly Joint Resolution 46, as affected by the adoption of assembly amendments 1, 2 and 4 thereto, constitutes a proper 2nd consideration of the amendment proposed by 1971 Enrolled Joint Resolution 26 so that, if 1973 AJR 46 in its present form is agreed to by both houses, the proposition could be placed before the people for ratification in compliance with section 1 of article XII of the constitution of this state.
