Resolved, That the department of justice is requested to report the results of its investigations and its recommendations to the assembly and to the assembly committee on agriculture not later than January 1, 1975.

Dear Speaker Anderson,

The purpose of this letter is to inform you and the Assembly membership of the first hearing to be held by the Natural Resources Committee under authority of ss. 23.09 (2) (d) and 27.01 (2) (a), whereby the Department of Natural Resources must secure approval of the Natural Resources Committees of both Houses to condemn land.

The hearing is on the request of the Department for authority to condemn approximately 360 acres in Door County within the project boundaries of Whitefish Dunes State Park. The hearing will be held jointly with the Senate Committee on Natural Resources and is scheduled for Monday, March 18, 1974 in Room 421, South at 2:00 p.m. The hearing has been noticed in the usual fashion.

Prior to establishing a procedure to conduct the hearing, the Senate by Senate Resolution 36 requested an opinion of the Attorney General as to guidelines. The opinion, which may be found commencing on page 2428 of the Senate Journal, states that the Committee may examine all relevant issues, but cautions that questions of price and value, if discussed openly, may prejudice later condemnation proceedings if approval is granted.

Accordingly, the committees will go into closed session if the members wish to examine these issues. The closed session falls within the permitted exceptions to the open meeting law see s. 66.77 (3) (d) and was suggested by the Attorney General.
