To the Members of the Assembly:

This is to inform you that on March 14, 1974, the Joint Committee on Employment Relations met and held a public hearing as to the tentative labor agreements arrived at between the state of Wisconsin and the Wisconsin Association of Science Professionals for employes assigned to the Professional Science unit, and the Wisconsin Federation of Teachers for employes assigned to the Professional Education unit, after which the Committee approved such agreements and terms thereof.

In addition, the Joint Committee on Employment Relations approved an act to amend that portion of the negotiated agreements between the state of Wisconsin and the Wisconsin State Attorneys Association (Chapter 79), the State Highway Engineers Association (Chapter 77), the State Association of Career Employees (Chapter 78), and the Wisconsin Nurses Association (Chapter 55) Laws of 1973, relating to the possible increased mileage allowance if during the term of these agreements the Legislature determines to amend section 20.916(4)(a) Wis. Stats. (1973)

In accordance with Section 111.92 Wisconsin Statutes, we are hereby introducing proposed legislation to approve and implement

such agreements and amendments to the existing 1973 chapter laws as listed above.
