JOINT SURVEY COMMITTEE ON TAX EXEMPTIONS

Assembly Substitute Amendment 2, to Assembly Bill 626

Public Policy Involved

As indicated above, this measure raises apparent constitutional questions. A specific constitutional exemption is provided for forest cropland and woodland. However, none is provided for wetlands.

For this reason, this bill is undesirable as public policy.

However, to the extent that this proposal attempts to classify such equipment as personal, rather than real property, it would very likely be unconstitutional and would discriminate against all other items of personalty similarly employed in a "permanent" situation. For these reasons, this bill is undesirable as public policy.
