INTRODUCTION AND REFERENCE OF RESOLUTIONS

Whereas, the United States Supreme Court has previously held that it is constitutional for a school district to loan textbooks to children in private schools if it loans textbooks to pupils in the public schools; now, therefore, be it

This bill is desirable as public policy.

Wisconsin has long recognized the equity and efficiency of severance taxes in lieu of property taxes on mineral rights.

This bill distributes the production tax revenues among all local governments, avoiding creation of tax islands. And, the mineral rights are discounted for property tax purposes only when the production tax is in effect, thus assuring sustained local revenues when mines are not in operation.
