GOVERNOR'S VETO MESSAGES

April 22, 1974

To the Honorable, the Members of the Assembly:

I have approved **Assembly Bill 589** as Chapter 198, Laws of 1973, and deposited it in the office of the Secretary of State.

I have, however, exercised the partial veto to eliminate certain duplicative funding and the Interdepartmental Council on Alcoholism, and to limit the powers of the Citizens Advisory Council on Alcoholism.

The partial veto with respect to funding eliminates the monies appropriated to the Department of Health and Social Services under Sections 20.435(2) (a) and (b) for 1973-74. The Department of Health and Social Services has advised me that these funds cannot be used before the end of the current fiscal year and has requested that the appropriation be removed from the bill. Chapter 90, Laws of 1973, provided \$1,242,000 to fund the programs mandated by **Assembly Bill 589** and, therefore, there are adequate monies available in the budget to fund these programs until the beginning of the next fiscal year. In fact, the appropriation in the bill for fiscal year 1974-75 together with the funds already appropriated in Chapter 90, provide funding for alcoholism programs beyond the levels originally anticipated as necessary and desirable.

I have eliminated the Interdepartmental Council on Alcoholism because its proposed functions are now, or will be performed, by other councils within State government. The Council on Drug Abuse has recently decided to undertake coordination and exchange of information functions identical to those which would have been exercised by the Interdepartmental Council on Alcoholism. The planning functions which would have been delegated to the Interdepartmental Council are now exercised by the Health Policy Council.

I have also exercised the partial veto so that the functions of the Citizens Advisory Council on Alcoholism created by the bill will be limited to formulating advice on the operation of the alcoholism program and other matters referred to it, and encouraging public understanding and support of the alcoholism program. The bill would have mandated that the Citizens Advisory Council also formulate advice on broad policies and goals. This is essentially a planning function which is now exercised by the Health Policy Council which has citizen input through its consumer members.
