Report of the office of emergency energy assistance  
to the governor and the legislature

November 5, 1974

**1. STATE SET ASIDE:**

In the past three months, the Allocation Program has been functioning smoothly with substantial quantities of product assigned in response to applications. For July, August, and September, 16,288,465 gallons were allocated to 909 applicants. 48 applications were denied, almost all because the set-aside of the supplier of the branded applicant was exhausted or because the problem which occasioned the application was resolved in some other way. A summary of applications granted and gallons allocated by type and county is attached.

**2. INFORMATION GATHERING:**

A. Petroleum - Administrative Rule OEEA 1 came effective on July 1, 1974 enabling us to require monthly information on inventories, receipts, and sales of petroleum products in the state from suppliers and distributors. Cooperation with the program has been excellent from the Wisconsin petroleum industry in spite of their understandable reluctance to fill out more forms and to divulge proprietary (i.e. confidential) information. Definitions are being refined and the data is being gathered. The information should be complete enough by the end of the year to provide reliable data for use in decision making. As soon as it is complete enough to be reliable, it will be put into an existing computer program so that

aggregate totals and trends can be pulled out without violating the confidentiality required by Chapter 157. The usefulness of the information will be somewhat limited until we have thirteen months of data so that comparisons can be made.

B. Coal - On July 1 we also began gathering information from coal distributors in Wisconsin but learned after investigation that most of the coal used in Wisconsin is purchased by the consumer at the mine and transported by the consumer. Thus, the information derived from our report relates to a small portion of the coal market. In view of the probable problems with coal supply this winter, we surveyed a list of major coal users supplied to us by the Department of Natural Resources and learned that most of them do not anticipate critical problems this winter. If a coal strike materializes as expected on November 12, we will again survey the consumers to determine the current situation. In the meantime, we are investigating other ways of getting ongoing data on coal consumption in Wisconsin.

C. Chapter 157 established an Energy Conservation Advisory Council under the leadership of Chairperson Mary Platner. The Council has worked diligently and will present a report to the Governor and Legislature in January of 1975. The report will contain a number of suggestions for Legislation that will encourage or mandate conservation of energy resources within the state.

D. A lengthy list of recommendations for conservation in energy management has been presented to the Governor. The principal need identified is the establishment of a comprehensive state energy policy. Having taken the first steps toward conservation, the attention of this Office will now be directed toward developing an outline for that policy which can then be subjected to public debate and finally drafted in the form of a legislative proposal. Such a proposal should probably be completed by the summer of 1975.

### 3. INSTITUTIONAL ARRANGEMENT:

Since Chapter 157 was written to self destruct on June 30, 1975 the 1975 session of the Legislature will need to consider the manner in which it wishes to gather information in the future. The next quarterly report of this Office will include a proposal for the assignment of responsibilities consistent with the needs of the state.

**Dear Legislator:**

Enclosed herewith is a copy of rules in final draft form, which the Hearing Aid Dealers and Fitters Examining Board proposes to adopt.

Pursuant to sec. 227.018 (2), Statutes, as created by Ch. 162, Laws of 1973, I also submit below a brief summary of the draft.

Chapter HAD 1 defines several words which are used in the proposed rules. Its purpose is solely to simplify the rules without any loss of clarity.

Chapter HAD 2 concerns trainees, who may be permitted to practice under supervision of a licensed hearing aid dealer. The chapter emphasizes the supervisor's liability for acts of his trainee, as provided by sec. 459.07 (2), Statutes, and limits the number of trainees a licensee may supervise, as required by sec. 459.12 (3), Statutes.

Chapter HAD 3 covers examination for licensing, including the types of questions which may be asked, subjects which may be covered, prohibiting cheating and taking examination questions from the examination room and providing for minimum passing grade of 70.

Chapter HAD 4 specifies appropriate procedures for measurement of human hearing and, pursuant to sec. 459.12 (2), Stats., methods for calibrating instruments used to measure human hearing.

Chapter HAD 5 provides for complaints against dealers, pleading and conduct of hearings in disciplinary matters and rehearings.

Pharmacy Internship Board**

**Re: Revision of Wisconsin Administrative Code Ph-Int 1**

Attached is a copy of the revised regulations for the pharmacy internship program in Wisconsin. It will provide the following changes:

1. Interpretation of the 12 month practical experience requirement of Wis. Stats. 450.02 (2) (a) as 365 calendar days.
2. An average internship practice week of 40 or more hours is credited as 7 days toward the 365 day requirement, and less than a 40 hour internship week may be credited on a pro rata basis.
3. Biennial certification of preceptors with a continuing education and professional affairs participation requirement of 20 units in the 24 month period preceding application. A limited amount of credit can be obtained for association officerships, committee memberships, and journal reading. A challenge exam, based on the current practice of pharmacy, in lieu of this 24 month requirement is optional.
4. Preceptors will be required to participate in a preceptor training conference at least once every two years.
5. The preceptor pharmacy must have been established a minimum of 12 months, and the minimum prescription volume requirement will be deleted.
6. The pharmacy practice must provide an environment in which pharmacist-patient and pharmacist-physician interactions occur at sufficient frequency.
7. Patient medication profiles of the nature that have been required since 1969 will now specifically have to be maintained and utilized by the preceptor and intern in the prescription area.

8. In a hospital pharmacy practice in which patient medication profiles are not maintained and utilized in the pharmacy itself, the preceptor and intern must review patient charts on a routine basis.
