TO THE HONORABLE WISCONSIN STATE SENATE:

PLEASE TAKE NOTICE:

That in accordance with Section 13.23 of the Wisconsin Statutes, I am serving notice that I am contesting the primary election process and results culminating in the State Board of Canvassers declaring MONROE SWAN the Democratic nominee for State Senator from the Sixth District in the City and County of Milwaukee, Wisconsin

That the cause of such contest is that there were numerous instances of fraudulent voting, and that said fraudulent intent affected the entire electoral process in said Sixth Senate district and constitutes a threat to the sovereignty of Wisconsin government.

That one, ROGER HANSEN, a candidate in said Democratic Sixth Senate primary was procured and fraudulently placed in nomination by employees and agents of the Concentrated Employment Program of Milwaukee, under the directorship of one, MONROE SWAN.

That Corrupt Practices Act violations took place in said election district with a design toward fraudulently influencing the outcome of the election. All of which actions have made a nullity of the Sixth District Democratic Senate primary election of September 12, 1972.

INTRODUCTION OF RESOLUTIONS

Senate Resolution 1

Relating to the rights and privileges of the senator from the 6th senatorial district.

Whereas, the election of the Honorable Monroe Swan to the 6th senatorial district has been duly certified by the secretary of state; and

Whereas, Senator Swan has taken and subscribed to the oath of office; and

Whereas, notice has been filed under section 13.23 of the statutes contesting the election of Senator Monroe Swan; and

Whereas, under Section 7 of Article IV of the constitution of this state the senate is the judge of the elections, returns and qualifications of its members; and

Whereas, said election contest has been referred to the senate committee on _____; now, therefore, be it

Resolved by the senate, That during the period of the election contest Senator Monroe Swan be given all the rights and privileges of other members of the senate, including the right to vote on all matters pending before the senate, except that he shall be denied the right to vote on any matter pertaining to or affecting the contest of his election.

Senate Resolution 2

Relating to organizing the 1973 Wisconsin senate.

Resolved by the senate, That:

SECTION 1 Vice president of the senate. The senate shall elect one of its members to serve as vice president, for the session, who shall possess all the powers and prerogatives of the president of the senate in the absence of both the president and the president pro tempore.

SECTION 2 Presiding over the senate. In the absence or inability of the president, president pro tempore, and vice president of the senate to preside, the person last presiding may name any senator to perform the duties of the chair temporarily, and who shall be vested, during such time, with all the powers of the president.

SECTION 3 Committee on committees created; duties. Senator Gerald D. Lorge as chairman, Senate Majority Leader Raymond C. Johnson, and Senator Reuben LaFave, are constituted a special committee on committees to report to the senate nominations for the standing committees and the chairmen thereof as constituted by the rules of the senate and, unless otherwise provided by senate rule, joint rule or statute, to all committees to

which senators are appointed under the joint rules or statutes as representatives of the senate, and to assign the seats to be used by each member of the senate in the senate chamber.

SECTION 4 Committee on interstate cooperation. The vice president of the senate shall be one of the 3 members, and shall be the chairman, of the senate committee on interstate cooperation.

SECTION 5 Committee on senate organization. The senate committee on organization shall consist of the vice president of the senate who shall be chairman, the president pro tempore, the majority leader, the minority leader and the assistant minority leader.

SECTION 6 Transmittal to assembly and executive office. Immediately upon the adoption of this resolution, the chief clerk shall transmit copies thereof to the assembly and to the executive office, notifying both that the 1973 Wisconsin senate is organized for the conduct of its business.

INTRODUCTION OF RESOLUTIONS

Senate Resolution 6

Requesting the President to not raise import quotas on nonfat dry milk.

Whereas, the U.S. secretary of agriculture is submitting a draft proclamation to the President that would raise import quotas of powdered milk from 1.8 million pounds to 25 million pounds; and

Whereas, the present situation of dairy farmers is one of severe income crisis. Costs are up drastically and there is an immense income squeeze. Present and future productive capacity is greatly threatened. The situation is one of emergency crisis, aside from the threatened flood of imports; and

Whereas, the threatened import flood would drastically worsen the present situation; and

Whereas, we already are absorbing heavy cheese imports with inadequate import control. Increased powder imports would have the purpose and effect of breaking powder prices. This would decrease farm income to 1970 or 1971 levels of income without compensating for the immense cost increases that have since occurred. Farm support prices for milk, already at less than 76% of

parity, would be pushed down below the legal minimum of 75%. This massive reduction in farm income would endanger the capacity to meet public needs for milk; and

Whereas, in effect the federal government has facilitated feed exports to enhance foreign production while opening import quotas in this country to allow such increased foreign production to destroy our markets. The effect domestically is to raise feed prices to farmers while lowering milk prices to farmers; and

Whereas, income of dairy farmers is now at a level that drastically threatens to shrink the productive capacity of the dairy industry. There have been increases in farm prices for milk during this past year, but costs have risen vastly more than prices. Feed costs have virtually doubled in parts of our country. Feed prices rose by 17% in the single week ending on December 13, 1972. Harvests are delayed or lost in other parts of the nation; and

Whereas, that flood of imported powdered milk would gravely compound the dangers to the dairy economy of an income situation that already is in a state of crisis. We are absorbing accelerating cheese imports in consequence of utterly inadequate import regulation. Increased powder imports must be intended to break domestic prices and incomes, and certainly that would be their effect. Dairy farmers already in real and deep distress will be driven from their farms. This action would deny over the long run an adequate supply of milk and milk products to our own people:

Now, therefore, be it resolved by the senate, That the President refuse to approve the proposal to raise import quotas on nonfat dry milk, not only for the interest of the dairy farmer but for the basic interest of the American consumer; and

Be it further resolved, That duly attested copies of this resolution be immediately transmitted to the U.S. Secretary of Agriculture, the President, the secretary of the senate of the United States, the clerk of the house of representatives of the United States and to each member of the congressional delegation from Wisconsin.
