5. On page 9, line 3, delete "Questions" and substitute "Other questions".

6. On page 10, lines 24 and 25, delete "editors of newspapers within the state and reporters for the press" and substitute "~~editors of newspapers within the state and reporters for the press~~ accredited correspondents of the news media".

7. On page 11, line 25, insert before the period "without debate".

8. On page 14, line 8, after "resolutions," insert "appointments,".

Amend the resolution as follows:

On page 14, delete the material in lines 8 to 10 and substitute:

"Senate Rule 18. **Daily calendar.** (1) All bills, resolutions, memorials, appointments, or other business, referred to a committee and reported by it to the senate with a unanimous recorded committee vote "for" and none "against" approval (passage, adoption, approval or concurrence) of the main question shall be

referred directly to calendar. The committee vote on amendments or subsidiary question need not have been unanimous.

(2) All bills, resolutions, memorials, appointments, or other business, referred to a committee and reported by it to the senate with any recommendation other than a unanimous recommendation for approval under sub. (1), shall be referred to the committee on calendar”.
