Senate substitute amendment 2 to Senate Resolution 5

Relating to stationery for members and officers of the senate.

Resolved by the Senate, That:

(1) The lieutenant governor as president of the senate, each member of the senate, and the chief clerk and sergeant at arms of the senate may each request not to exceed 12,000 sheets of letterhead, and not to exceed 12,000 envelopes, from the department of administration.

(2) All printing under this resolution shall be done by the lowest responsible bidder in compliance with article IV, section 25, of the constitution of this state.

(3) Any person entitled to stationery, including envelopes, under subsection (1) may elect to have it printed by a printer of his won choice provided subsection (2) is complied with. The committee on Senate Organization shall not approve the voucher for any stationery to be printed other than through the Department of Administration unless the cost of such stationery, including envelopes, will be the same, or less, as the cost of providing the stationery throught the Department of Administration.

(4) The design of each person's letterhead and envelope must be approved by the Committee on Senate Organization.

(5) Any person entitled to stationery under sub. (1) may specify that this stationery shall be produced using recycled paper.
